



Information on PRIVACY according to GDPR 2016/679 (General Data Protection Regulation)

Dear Guest,

we would like to inform you that GDPR 2016/679 (regarding the protection of personal data) safeguards the protection of persons and other subjects regarding the processing of personal data.

According to the GDPR 2016/679, this data handling is based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Therefore, according to article n. 13 of GDPR 2016/679 we hereby transmit the following information:

1. The personal data you give to VEGA SCHIAVONI SAS di Tegon Martina & C., the controller, will be handled for the following purposes:
 - a. Management of your booking request
 - b. fulfilment of tax and accounting obligations related to the established commercial relationship
 - c. sending your personal information to the public authority as required by current legislation
 - d. furthermore, subject to your explicit consent, your data may be used for sending advertising and publicity material to the addresses provided by you and concerning our services (for examples new services, promotions, etc.)
2. The processing of personal data will be carried out both through IT tools and manually by specially appointed employees. Your personal data will be stored in our paper and digital archives and in any case on the national o European territory.
3. As part of the treatments described above it is necessary to know and memorize all the data necessary for the management of your request, such as, for example, the company's personal details, telephone contact number, e-mail address, etc. Any refusal to provide such data could lead to failure or partial execution of the contract.
4. The personal data you provide will be communicated to authorized third parties for the fulfilment of legal obligations and for the management of your reservation. In this regard, the data may be disclosed if necessary:
 - a. To public authority in charge exclusively for purposes related to the execution of the service requested by you
 - b. to business consultant specifically appointed for the fulfilment of legal obligations
 - c. to web agency specially appointed to manage your reservation
5. The personal data you provide, will be processed and stored for the purposes set out in points 1a, 1b and 1c in our paper and digital archives for the time required by law. If you consent to point 1d of this privacy policy, your data may be stored in our paper and digital archives until you revoke the authorization by sending an email to info@palazzoschiavoni.com. Subsequently the data will be deleted from our archives or destroyed in compliance with current legislation
